



Dear Financial Aid Applicant:

Enclosed is the 2010 financial aid application. Please fill out and return it to the Herzl Camp office, along with your 2009 tax return by February 16, 2010. If you have not completed your 2009 taxes by February 16, please send your 2008 tax return so that we may begin to process your application. **Applications will not be processed until we have received your 2009 return.** Although aid can be designated, no monies can be released until the 2009 tax return is supplied.

Also, please make sure to apply to all agencies from which you are eligible to receive financial aid. Residents of Minneapolis may apply to the Minneapolis Federation. To receive an application for a Federation camp scholarship call Ann Kaner-Roth at 952-417-2343. Residents of St. Paul should apply to the United Jewish Fund and Council at 651-695-3183 (Laura Savin). You should also check with your synagogue or Hebrew School regarding their criteria for scholarship applicants.

Herzl Camp financial aid grants are based solely on need and our applicants are completely anonymous to the committee members. You will be notified of your award by April 15, 2010, unless you have applied to other agencies for financial aid, in which case we will notify you after we have heard from them. As financial aid is intended to lower the cost of camp, you will still be responsible for a portion of your tuition. You must make monthly payments either through automatic withdrawals, credit card payments, or post-dated checks. Please contact the office to determine your monthly payment amount.
